Subject: Commitment to Zero Tolerance for Sexual Exploitation and Abuse (SEA) by UN and Related Personnel

We, Heads of Agency of the UN Country Team (UNCT) Liberia commit to the Interoffice Memorandum signed by the Resident Coordinator of Liberia on the UN Zero Tolerance for Sexual Exploitation and Abuse dated 25 January 2017, as outlined in the Secretary-Generals bulletin on Special Measures for Protection from Sexual Exploitation and Abuse, ST/SGB/2003/1.

We remind all staff, national and international, of their obligation to become aware of and abide by the standing regulations regarding Protection from Sexual Exploitation and Abuse (PSEA), including the obligation to report any concerns or suspicions regarding sexual exploitation and abuse to the appropriate office/focal points.

On 25 January 2017, The UN Country Team re-launched the Liberia in-country Network on Protection from Sexual Exploitation and Abuse by UN and related staff, which was not active during the Ebola crisis. With this commitment we the undersigned are dedicated towards strengthening the coordination, prevention and response within our respective agencies and sphere of influence, and expect staff members' full cooperation (Signatures appended below).
